Yep, it's me! I'm here in Dallas. It's been a bit of a year, but things are getting put back together. Things were reported a lot worse than what really happened, or is happening. The SEC case was settled 2 days after they showed up in our offices. It's a bit of a long story, but we had been working with the SEC for over a year, they knew everything we were doing, and that had invested the money in real companies, with real revenues/operations. They didn't really care for our business model, and because we didn't disclose a couple of things properly, they shut us down. This typically results in a fine of some type, but shut us down...then 2 days later, the SEC came to us with a settlement of No Guilty Plea, No restrictions or bars from the industry, do defined fine.

The investments are still ongoing... No investor has lost any money. We have a very antagonistic receiver, who really hasn't acted in the best interest of the investors, in my opinion, so the investors got an attorney to try to make sure that the receiver doesn't harm them.

Even though the SEC case has been over for a while for me, because we have an antagonistic receiver, my attorneys recommend that I don't reach out to any investors, which is why I haven't talked to Ray, but he can call me... Even the receiver makes no mention of stolen money and the SEC concedes that the money was invested and used on operating expenses. It's really unfortunate, because we had a really good thing building, and because we failed to disclose to things, the SEC used that to take us out.

The good news is, that the investments are still ongoing, and at present, it seems that the investors stand to make a good return. I'm happy to talk to Ray if he wants to reach out.

So, I'm rebuilding...gonna stay away from the SEC for a bit, but, they said I can go build another fund, which is really strange if they really thought I did, what I was being accused of.

Glad to hear you're doing well, and glad to hear you're still loving Spanish.

I hate hearing about Joy. I've not heard, and that makes me even sadder. I'll try to reach out.

Let's get together when you can break away.
